ORDER

Whereas, the Assam State Disaster Management Authority (ASDMA) has vide order No.ASDMA.28/2021/ 148 dated 6/7/2021, issued stringent directives for effective containment of Covid-19 pandemic in the state;


Whereas, the positivity rate of Covid-19 cases in Golaghat district has shown slight improvement necessitating a revisit of the existing directives.

Now, therefore, in exercise of the powers conferred upon me u/s 34 (b) (c) (h) & (m) of the Disaster Management Act, 2005, I Shri Mrigesh Narayan Barua, ACS, District Magistrate & Chairman, DDMA, Golaghat, do hereby issue following directions which shall come into force **from 5:00 AM of 16 July, 2021 and shall remain in force until further orders:**

Restrictions imposed:-

| 2 | All Religious Institutions | Closed |
| 3 | Opening of workplace and business/ commercial establishments | Closed |
| 4 | Functioning of Government and Private Offices/Establishments. | Closed |
| 5 | Opening of Shops and commercial establishments | Closed |
| 6 | Shops dealing with groceries, fruits and vegetables, animal/ poultry fodder, fertilizer shop | Upto 1 PM |
| 7 | Dine in Restaurants, Dhabas and other eateries | Closed |
| 8 | Takeaway of food items from restaurants, Dhabas and other eateries. | Upto 5 PM |
| 9 | Opening of Sale counters, showrooms, Mall | Closed |
| 10 | Cold Storage | May be opened for maintenance purpose upto 1 PM |
| 11 | E-Commerce warehouses | Upto 3 PM |
| 12 | Whole sale grocery and Warehouse | Upto 2 PM |
| 13 | Pharmacies (both human/animal), milk booth | Can be opened 24 hours/ or usual working hours |
